GENERAL

- Welcome
- Arrival and departure dates established
- Intended or approved activities endorsed
- Requirement to stay at designated camp site
- Motor bikes/4 wheelers/quads – none permitted on property
- Hunting dogs – none permitted on property
- Pets – identified and to remain at camp site
- Gates and fences – leave as found
- Privacy provisions - respect for other campers
- Use of telephone – emergencies only
- Damage to property – report to Management

HEALTH

- Rubbish – removal of all food and material waste DO NOT BURN
- Hygiene– you need to bring a porta potti or portable toilet

SAFETY

- Environmental hazards – ensuring campers are aware of these
- Safety equipment – requirement to have a personal first aid kit
- Water supplies – need to supply own
- Use of two way radios – Karma Waters on channel 3
- Cattle/ horses – do not approach
- Feral animals – do not approach
- Weapons – none permitted on the property
- Fire safety – restricted to camp site
- Injuries – requirement to report these to Management
- Roads – drive to the conditions

I further acknowledge and agree that I have undertaken the activity freely, voluntarily and absolutely at my own risk and with a full appreciation of the nature and extent of all risks involved in the activity. This waiver shall bind me and my executors.
